Recommended Substrate Conditions & Preparation

Surfaces are to be suitably prepared in accordance with proper trade practices.

New Timber and Cork Surfaces: Ensure surface to be coated is thoroughly dry, and free from dirt, grease and wax. Fill all nail holes and cracks in timber with a suitable Timber Putty. Sand all new timber and cork surfaces to a smooth finish and vacuum floor thoroughly to remove all dust.

Surfaces Previously Coated with Clear Finishes: Fill all nail holes and cracks in timber with a suitable Timber Putty. Sand the entire surface thoroughly, ensuring that no gloss remains. On aged timber floors, mechanical sanding is recommended, to ensure that satisfactory adhesion is achieved. Vacuum thoroughly to remove all dust.

Application Guide

Apply 3 full even coats using a paint pad or a suitable brush.

Use the brush to cut in around the skirting boards, corners, edges etc.

Use a "moving puddle" technique to apply.

Pour an amount of product onto the floor and use the paint pad or applicator to move product around, using a mopping motion. Ensure that the floor has a smooth even coating, and always finish with strokes along the grain. Do not apply excessively heavy coats.

Subsequent coats will result in a higher gloss level and film build. Sand Sand lightly between the 1st and 2nd coats to remove any raised grain using 240 grit sandpaper. Sanding should not be required between additional coats.

Do not apply when temperature is below 10°C or above 35°C or when humidity is very high.

The temperature must not fall below 10°C during the drying process.

Maintenance

Sweep floors regularly. Clean with a soft mop and household detergent in warm water.

Additional Data

Available in 1 & 4 litre containers.

Under normal drying conditions (20°C) Easyfloor Clear Finish is touch dry in 30 minutes and can be recoated in 3 hours. In cooler conditions, white streaks may be noticed during drying. Do not recoat until these streaks have completely disappeared.

Floors may be subjected to light traffic 24 hours after applying the finishing coat and will be completely cured in 72 hours.

Wattyl do not recommend the staining of timber floors, as staining may highlight surface imperfections.

Do not apply this product by spray or roller.

Containers must be secured and stored upright during transit.

Containers must not be exposed to excessive heat or cold.

Store in a secure, cool and well-ventilated place. Keep container tightly closed.

The use of proprietary additives other than those manufactured by Wattyl is not recommended.

Do not use for any other purpose other than as specified in our literature.
